APPLICATIONS:

Insecticide for professional use against flying and crawling insects such as Cockroaches, Crickets, Silverfish, Bedbugs, Booklice, Ticks, Fleas, Mites, Ants, Mosquitoes, Moths, Wasps, Centipedes, Flies and beetles.

Application can be made to both porous and non porous surfaces and hard and soft furnishings. Use areas include domestic, commercial and industrial properties such as residential properties, offices, hospitals (excluding occupied wards), kitchens, restaurant as well as public and municipal buildings, food storage and processing areas, refuse tips, slaughter houses, manure heaps and in animal husbandry.

DIRECTIONS:

Place 25ml into 5 litres of water and mix well prior to application. Spray diluted product at a rate of 10ml²-20ml² depending on severity of infestation and porosity of surface.
5 litres of dilution is sufficient to treat 500m²-1000m²
